One question I have about the new CTA Cermak Green Line stop: WHY?

So everyone's buzzing about [the new \\$50 million Green Line Cermak stop](#). I want to know why. There's already a Red Line stop [less than two city blocks west](#). So why did we waste millions on a new CTA train stop so close to the old one? Especially a new one that looks like the midsection of an enormous rattle snake?

If it went right into McCormick Place, I could see it. It would be nice for MP visitors, conventioners and employees. But the new stop only gets less than two blocks closer to MP than the already existing (and newly fashioned) Red Line Cermak stop. That's less than a five minute walk. Less than a minute by bus.

Well, the Green and the Red do double duty at 35th Street, one might argue. Why not at Cermak, too? The answer: Sox fans. At least there, thousands of people get on and off thousands of times from April through September and maybe a double train makes a modicum of sense.

But there is absolutely no reason for an extra stop at Cermak. It's a complete waste of money.

Yes, someday [there will be a Motor Row entertainment district](#) on Michigan Avenue, moving south from Cermak. But again, the Red Line Cermak stop alone would have served that area well when it happens. And yes, there are more and more residents moving into the south end of the South Loop. Again, the Red Line (and a number of buses on both State Street and Michigan Avenue) serve them well already. And [the new DePaul Stadium coming to the area](#)? Ditto. The Red Line and the buses are just fine to get people there, too.

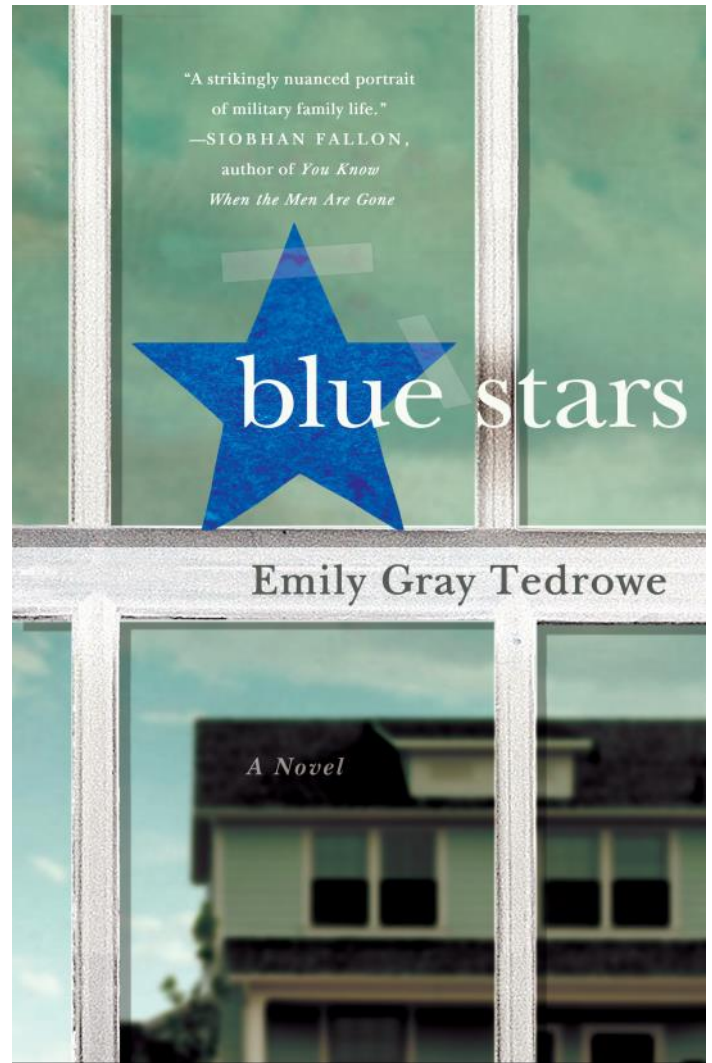

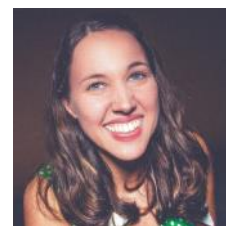

Books will be available for purchase and the author will sign books at the conclusion of the program. Admission is first come, first serve; reservations not required.



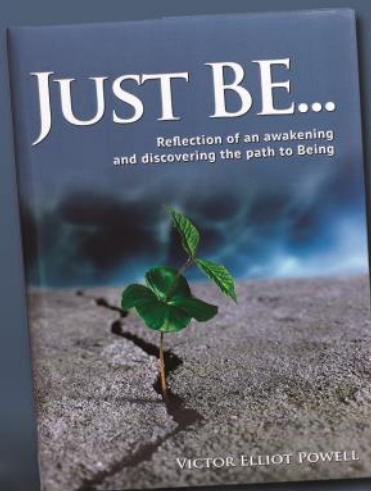

Safe & Sound Blog

Four different editors at University of Illinois Press went over the rough draft of my memoir before they published it. All of them suggested changes.

One of the most common request? Stronger verbs. They also wanted descriptions that were more precise, more colorful, more heartfelt. Now, 12 years after [my memoir, *Long Time, No See*](#) was published, I am leading four memoir-writing classes every week and urging writers to, you guessed it: use stronger verbs and include precise, colorful, and heartfelt descriptions in their writing. The requests from my editors forced me to return to certain settings in *Long Time, No See* and focus on how events at hand made me feel at the time. Not always easy. Some of the most life-altering events in our lives are ones we'd rather forget.

An example: Surgeons operated on my left eye first. That surgery was unsuccessful. The first Try with my right eye didn't work, either. They operated on it a second time. Each surgery was painful. Each required month-long stays at the hospital to recover, and I had to keep my face down every minute of every day of those long months away from home. My head was down when I "watched" television, when I listened to books, when I walked to the bathroom. I slept with my face in the center of a donut "hemorrhoid" pillow – eye surgeons didn't want to risk me turning my head in the night.

In *Long Time, No See* I write about the retina surgeon examining my eyes after the third surgery and breaking the news to Mike and me that I'll never see again. In the rough draft I told readers that after hearing this, Mike and I walked out of the office and headed to White Sox Park for a baseball game. Whoa! Whoa! Whoa! University of Illinois Press editors read that and said I absolutely must tell my readers what was going through my head when we found out my blindness was permanent. Not exactly a moment I wanted to relive – who wants to re-enter that room and hear that bad news all over again? In the end, though, rewriting that scene turned out to be GREAT therapy. I had to think. When I was told I'd never see again, was I disappointed? Angry?

Sad? Scared? The answer is here, in an excerpt from the published version of *Long Time, No See* (University of Illinois Press, 2003):

"I'm afraid there's nothing else we can do," he said in a tone I recognized from his final report on my left eye.

All I could think to ask was, "Can I lift my head up now?"

He said I could. Thankful for at least that, I raised my head for the first time in over a month. I was struck by a sudden feeling of freedom and relief. No more lasers, no more operations, no more weekly visits to Chicago, no more worrying whether or not this all was going to work. We'd been at this for nearly a year; now it was finally over.

I swiveled my head as if to look around. I saw nothing. Mike talked to the doctor, asking sensible questions, I suppose.

Turning toward their voices, I asked if this was really it, if we'd really exhausted the possibilities.

"I'm a religious man," the doctor answered, "and in the religion I follow we believe in miracles. I believe God has cured all sorts of ailments. This could happen with you, but there's nothing else I can do for you medically."

We stood up to leave. I reached out for the doctor's hand.

He clasped mine with both of his, and I thanked him for all he'd done. He was shaking. I felt sorry for him; I would've liked to tell him we were going to be all right.

The White Sox were in town that day. Going to a ballgame after learning I'd be blind for the rest of my life was probably a strange thing to do, but it beat heading home and sitting on our pitiful second-hand couch and wondering where to turn next. From the book:

The White Sox were having a rotten year. There were maybe 8,000 people in the stands; Floyd Banister pitched, the Sox lost. But it was strangely pleasant, sitting next to Mike with my head up, not giving a thought to eyes or surgery. We each had a bratwurst and a beer. Between bites and gulps and giving me play by play, Mike bantered with other fans, cursing the underachievers on the team. I laughed at Nancy Faust, the Sox organist—she's famous for picking songs that play on player's names. Mike marveled at the endurance of Carlton Fisk, and we both wondered out loud why every time we went to a game, that bum Banister was pitching.

The three-hour ride home was quiet, and once we got there, we found ourselves sitting on our miserable couch, just as we'd feared, holding hands and trying to imagine how we'd cope. Our only decision that night was to go to sleep, and today being Valentine's Day, I'll end the post with that steamy scene -- editors agreed with me that it didn't need more description than I had in the rough draft! *Our bed felt wonderful. I was home for good. Despite everything, a powerful relief came over me, a sense of security, such a change from how I'd felt during those months in my hospital bed. And I realized right away that sight isn't needed under the covers.*

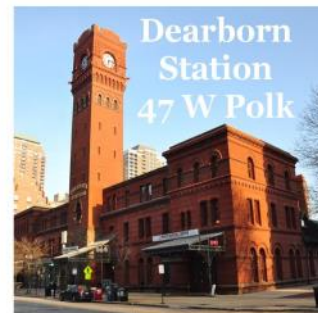

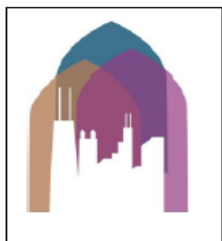

To the Residents of Dearborn Park:

It has occurred to me that many of you, particularly those of you who have moved to Dearborn Park in the last few years, may not be familiar with the origins and philosophy that prompted the development of the new neighborhood in which you reside.

Approximately seven years ago, a group of Chicagoans called the Central Area Committee presented a development plan known as "Chicago 21" for the entire central area of the city. The segment of this area from Polk Street to 15th Street and from State to Clark, comprising of some 52 acres, was designated for residential construction.

As no developer was interested in providing housing as suggested by the plan, a small committee was formed, of which I was one, to procure the equity money needed for the acquisition of the land, and the construction of the first 1,000 dwelling units for middle income purchasers, as well as housing for the elderly. The principal financial and business organizations in the central area put up approximately \$14,000,000 for equity and we procured construction loans totaling \$73,000,000.

It was decided that a new neighborhood should have a variety of housing types in a suburban environment with adequate recreational facilities. We therefore selected separate architects for the site plan, and for each type of housing - the town houses, mid-rise, high-rise and the elderly building - five architectural firms in all. We also employed a firm of construction managers with a national reputation.

Our goal was to provide housing that was the best buy in the entire Chicago area. We achieved this in two ways. First, the Dearborn Park Corporation was formed as a limited dividend Corporation so that the investors would be limited to a return

of six and one half percent on their investment, (incidentally in seven years they have received no return whatsoever.) Second, we were successful in securing mortgage money at interest rates from three to five points under the market.


From the beginning, it was the hope of the Board of Directors of Dearborn Park, that the success of our project would be the catalyst that would spark other developers both to rehabilitate existing buildings and construct new housing in the area.

Testimony to the achievement of our hopes is evident by the following:

1. The condominiums are 96% sold out.
2. Parks, tennis courts, swimming pools and jogging tracks are in place.
3. Printers Row is well on its way to complete renovation.
4. New developers are constructing more housing and facilities.
 - a. 2 East Eight Street
 - b. River City
 - c. Town houses east of tennis courts
 - d. Renovation of the Dearborn station
 - e. Board of Education has funds for an 8 grade elementary school
5. The city has agreed to put the infrastructure in the area south of Roosevelt Road, thus making it ripe for further development.

It has been very gratifying to me, both as one of the earliest occupants of the development and as Chairman of the Board of Draper and Kramer, to see Dearborn Park attain the goals which we hoped for when the Dearborn Park Corporation was first formed.

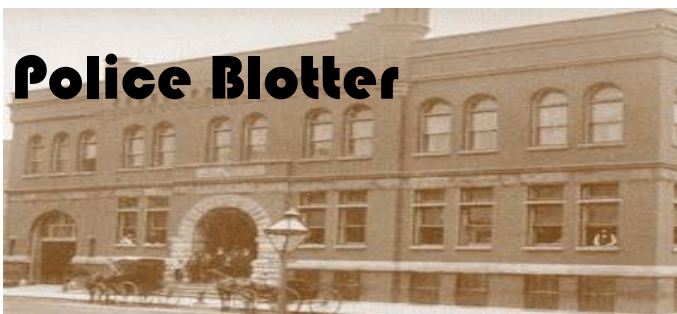

South Loop Robbery Suspect Arrested Amid More Foot Patrols, Police Say

DOWNTOWN — A boy accused of robbing victims at gunpoint Sunday in the South Loop has been arrested, a Chicago Police captain said Wednesday.

Capt. Laurel Bresnahan also told a small community group gathered at the University Center, 525 S. State St., that more officers are patrolling the neighborhood in response to an uptick in crime, including armed robberies.

The boy has been charged with two counts of armed robbery and one count of attempted armed robbery, according to a police spokesman, who declined to comment further.

The boy arrested in connection with a [Sunday robbery in the 1200 block of South State Street](#) approached his victims by asking for the time before brandishing a handgun and taking money and cellphones, police said. The crime is similar to robberies reported Saturday in the 100 block of North Beaubien Court and the 300 block of South Water Street, police said.

The arrest follows a rash of robberies in the South Loop, where all reported crimes increased 60 percent — to 85 from 53 — from Jan. 14 to Feb. 8 compared with the prior 30-day period, according to Chicago police statistics disclosed at the CAPS meeting Wednesday. The statistics apply to a police beat stretching from Congress Parkway to Roosevelt Road and from Michigan Avenue to the Chicago River.

Reported batteries on the beat increased from three to 12 over the same time frame, and robberies increased from one to four, police said. Bresnahan told residents that the crimes followed a similar pattern, with the victims, all young women, attacked from behind from 4-8 p.m. on Tuesdays and Fridays.

Bresnahan said more foot patrols have helped reduce crime, but she advised residents to be good neighbors and warn distracted, headphone-wearing women walking or jogging in the area.

"We ask people to keep a friendly eye out," Bresnahan said.

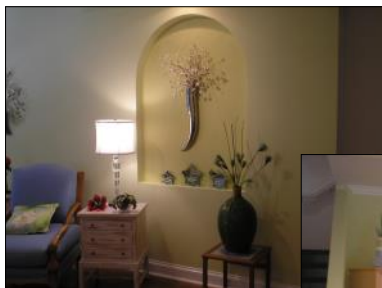
