### A Concept for High-Profile Parking Lot in Printers Row (SE Corner of Dearborn/Harrison) 7/7/2016

A reader writes:

Interesting proposal/concept for the current parking lot in Printer's Row on the corner of Harrison & Dearborn - be sure to scroll through the pics.

This appears to simply be a concept by local architecture firm, MGLM. This is what they say about it on their website:

Envisioned for a narrow empty site near the heart of Chicago, this mixed-use infill building creates amenities the area currently lacks.

The design responds to a broad need for sustainable, hyper-local developments encouraging pedestrian traffic and revitalization in formerly industrial urban areas, as well as the specific needs of the Printer's Row neighborhood itself. Nine adjacent universities lie within a tenminute walk of the site, but no grocery stores. With a major grocer to anchor the building at its base, the 170 loft apartments above provide needed housing for students and others connected to the universities.

The building's brick façade and terra cotta details complement the unique architectural identity of this former printing center of the Midwest. The well-known 19thcentury Chicago loft aesthetic is continued with large windows, lending each unit plentiful natural light and skyline views.

It does seem baffling to us that this high-profile piece of land hasn't been developed in some manner. A parking lot seems like such a waste of a great lot. Eventually we imagine that will change, but in the meantime we will continue to just scratch our heads.

Also, the point about the grocery store seems interesting to us. Printers Row doesn't have a grocery store, but

there are a ton on Roosevelt and it seems like their are a decent amount of convenience stores if residents can't walk/drive to TJ's, Jewel, Target, Whole Foods or Mariano's.

The following post was Bonnie McGrath's last post on the Lucas Museum controversy before Lucas decided to pull out of Chicago for greener pastures. This post recently won one of the Top 10 posts awards from Chicagonow for June, 2016.

With all the Lucas Museum stuff going on these days, there seems to be one big thing missing: Lucas

So where is that guy? George Lucas? Are you there? <u>Friends of the Parks has a number of things it wants to run by</u> you. They want you to give our city a few things and in return, they may agree to let the city tear down Lakeside Center--an iconic landmark of a McCormick Place building on the Lake-so you can put your Lucas Museum of Narrative Art there. What do you think of the things they want? Will you give those things to us? Do you feel generous and giving? Or do you feel you are already giving enough by bankrolling the museum and donating your personal art collection?

They want five percent of the museum's income to help bankroll Chicago park improvements, George. And they want you to help flesh out the long-awaited <u>DuSable Park</u> with your own cash. And they want you to create a nice green space in the Soldier Field parking lot that you originally wanted for your museum--so that families and sports enthusiasts and tailgaters can enjoy it. Will you throw that stuff in to sweeten the pot so that maybe you can build your legacy?

What do you say? What does your museum board think? Where the heck are you?

We haven't heard a peep out of you. The head of the Park District board, Jesse Ruiz we've heard from. <u>He called FOTP ex-</u><u>tortionists</u>. Which is a hell of a thing--because FOTP wants you to give things to the very city agency whose board he heads: the Chicago Park District. He should like what they want you to do because it benefits the Chicago Park District and Chicagoans, whose best interest he is supposed to be looking out for.

So his behavior makes no sense.

Tiny dancer also says no way, Jose about what FOTP wants you to give our city. Which also makes no sense--because FOTP wants you to give us some extra goodies for the privilege of building here. What mayor in his right mind turns down extra goodies?

Is it all true? Have you told Ruiz and Rahm that you won't give those things to us? If so, why not? What's wrong with sweetening the pot a little, George? Are you going to leave Chicago and get your museum built somewhere else? Do you get the feeling that maybe R and R don't want you around and that they're just faking our city out by pretending to speak on your behalf, thereby turning FOTP and their supporters away so that you'll leave?

Are you nixing everything? If so, when did you do that? Do those two represent you? Why are they doing your talking? Are they your agents? Are they your best buddies? Do you like that they speak on your behalf?

It sure seems odd to me that the mayor of Chicago and the president of the Chicago Park District board are nixing extra gifts for their city and for their parks, respectively. Things that you may want to give our city. Do you? Those two have a duty to get things for us--and yet they turn down things that you can afford and that you may feel perfectly fine about giving us. But we have no idea if you're perfectly fine about giving those things to us. You won't come out and say what you're thinking. Or feeling. Why don't you tell your board where you're at with all this and have them say something definitive? Your board can speak for you. How come they don't? Are you perfectly fine about giving us that stuff? If not, why not? If so, why don't you tell us you are



fine with those things? Or that you'd like to negotiate? Or that *you* think FOTP is out of line?

Why not fight mano a mano on your own behalf? Or have your board negotiate? Board to board? How come Rahm and Ruiz do all your talking? Are they telling us the truth about you? That you think FOTP are extortionists? That you'll soon be leaving Chicago?

Chicago has a lot of inquiring minds. And we want to know. Right now, all we know is that Rahm and Ruiz are turning these things down. That they're being mean to FOTP. And not accepting things for us that you may be very willing to give. And that we deserve to have.

They say that the city and the park district won't even consider taking these things from you. Are you happy about that? They should be on our side and encourage you to sweeten the pot in exchange for letting you build your museum on our lakefront, you know. But they don't say thank you to FOTP for asking for more from you. They shout at them and they imply that you would like to shout at them, too. But you don't shout on your own behalf. You don't even whisper on your own behalf. Rahm and Ruiz just call FOTP names and say you're hitting the road.

So where are you? Have you hit the road? Do you even know that FOTP wants to negotiate a deal and get this whole megillah out of the way?

Maybe you want the case to continue in federal court? Winner take all: Either you get to build wherever your heart desires on the lakefront--or you don't. Do you want the judge to decide your museum's fate here in our fair city? It's your call, George. But first things first: you gotta make a call.

We'll be waiting. The whole city is waiting. The judge is waiting.

## **Chicago High-Rises Could Be Fined Thousands For Recycling Violations**

CITY HALL — A City Council committee endorsed stiff new fines for recycling violations Monday, but only as a "last resort" to compel compliance.

In a bid to get larger complexes from six-flats to high-rises to join in recycling, the Health Committee endorsed a hike in fines for not participating in recycling from the current \$25-\$100 range to \$500-\$1,000 for the first offense, \$1,000-\$2,500 for a second within 12 months and \$2,500-\$5,000 for subsequent offenses.

"I don't see it working as it should," said Ald. George Cardenas (12th), committee chairman, on the city's recycling program. "We need to do something drastic."

To that end, the Emanuel administration presented an overhauled recycling ordinance Monday intended to compel compliance through those stiffened fines.

Commissioner Charles Williams, whose Department of Streets and Sanitation will be charged with enforcement, said, "Our goal is to get good recycling going in the City of Chicago."

According to Williams, Streets & San trucks now service 600,000 single-family households across the city through the blue-cart program fully implemented in 2013, but it only serves up to four-flats. Larger apartment complexes and condominiums are expected to provide their own recycling through private firms.

"Claire Miklin, founder of Chicago's <u>My Building Doesn't Recy-</u> <u>cle! webpage</u>, testified Monday that the honor system wasn't working. "The problem was the very limited enforcement of the original recycling ordinance," she said.

Williams granted that only 197 citations for failure to recycle had been issued over the last 10 years, but said that would be changing, albeit with a continuing emphasis on compliance over punishment.

We intend to work very closely with the owners and associations," Williams said. "It is not our intent to go out and start hammering folks with tickets." He called issuing citations "our last resort when we get no cooperation whatsoever."

Cardenas said he expected the new fines to "entice" compliance, especially among "bad elements" and "absentee landlords."

Yet Brian Bernardoni, spokesman for the Chicago Association of Realtors, opposed the ordinance, calling it "unduly onerous," with fines that are "significant."

Ald. Willie Cochran (20th) was sympathetic, saying he didn't think it fair to go "blaming the landlords" for violations.

Ald. Brian Hopkins (2nd) agreed, but only up to a point, saying, "The fine should be enough to really get your attention."

"Someone has to be accountable, and it has to fall on the landlord," Williams said.

As a result, the committee backed the ordinance, while adding new language allowing first for a 30-day warning notice before fines kick in.

Fines for placing <u>banned items in a recycling cart</u> would remain in the \$50-\$100 range, with Williams allowing that enforcement posed a problem in that area.

"We're not going to issue a citation just because a cart is contaminated, because we don't know who did it," he said. In cases where a complaint is received and a certain person is found to have contaminated a cart, he added, Streets & San workers wouldn't hesitate to write a ticket.

With the addition of the 30-day warning, the proposal passed without opposition and heads to the full City Council for final approval on Wednesday.

# Mary Kay Andrews' *The Weekenders* (St. Martin's 2016) Book Review, July 17, 2016

Mary Kay Andrews' The Weekenders takes us on a breezy get-away to Belle Isle, somewhere in the sunny, surfkissed Carolinas, where all the women are beautiful, all the men are rich, and seafood is all-you-can eat. We denizens of Chicago have enough sand, water, and other peoples' yachts to justify reading a New York Times Bestseller, stretched out on a blanket, slathered in sunscreen and sipping a salty dog. Though Chicago more resembles Helsinki than Hilton Head, all two million of us should kick back ever so briefly and escape into other people's slightly more entertaining and less taxing lives. The Weekenders is like enjoying a good romcom without having to go inside and sit in the dark. Meeting the funny, friendly author, whose real name is Kathy Hogan Trochek, at the Dearborn Park neighborhood yard sale just a few hours before she was to speak to her admiring fans at the Chicago Lit Fest moved this reviewer to give her a try. The Weekenders is a great read for chillin' on the chaise lounge, riding on the red line or juggling on the Jeffrey Jump. It has everything: dead bodies, betraval, larceny, adultery, teenage drama, unrequited love---and even a hurricane. Not to mention attractive, funny, intelligent, women (including the dead one); sensitive, successful men with a surfeit of manly skills

She does so honestly, but humorously, not unlike a David Sedaris memoir. Andrews told an interviewer that her "fictional families... put the fun in dysfunctional. "She's spot-on for the privileged Southern set she describes, and if you've never owned or rented or been invited to a fancy beach house with a history as sordid and interesting and as old as the beachfront it sits on, a couple of hours with Mary Kay Andrews will introduce you. Drinking, eating, sailing, fornicating, and occasionally killing each other is pretty fun with an author who says of her typical subjects:

"We don't just accept eccentricities, we celebrate them. Instead of hiding our klepto cousin in the basement, we tend to set them right out on the front porch and say things like, 'Bless her heart, she never could resist taking that fivefinger discount.' " Write on, Mary Ann. We need a vacation from crisis.

### Woebegone but not forgotten

Our quest blogger John *Craib-Cox is the proud father* of a son and two grandchildren in London and a daughter and granddaughter here in Chicago. He signed up for a memoir-writing class shortly after his wife Tessa died unexpectedly on July 17, 2012. That was four years ago today. She was 67.



Today's guest blogger, John Craib-Cox.

Tessa Craib Cox was born in England and met John when she was on a graduate fellowship at New York's Metropolitan Museum of Art in the 1970s. Young newlyweds John and Tessa moved to Chicago in 1974, the same year <u>A Prairie Home Companion</u> first aired. The poignant piece he read in class last week about Garrison Keillor's final appearance as host of that show is a beautiful reflection on love, family, nostalgia and loss.

In 1974 Public Radio began to broadcast A Prairie *Home Companion*. At the time, with two small children and few satisfactory baby sitters, weekend evenings were spent in our apartment and this program became a welcome source of entertainment.

The host, Garrison Keillor, was roughly our ages, and had a familiar dry sense of humor and similar musical taste. This proved to be a winning combination. Friends also liked the weekly program and it provided many shared subjects for conversation.

Many of our friends had grown up, like me, in the Middle West and found Keillor's Lake Wobegone reminiscences struck a familiar regional note. Our children liked the ragtime music heard on the broadcasts. They would dance whenever the band played something bouncy and up tempo.

Throughout the '70s we weekly would listen together to Garrison Keillor on the radio, and whenever he was at Ravinia Park we would be in attendance. Keillor had a wonderful sense of the absurd. As they grew, our children would laugh whenever he referred to the freezedried mouse morsels obtainable at Bertha's Kitty Boutique.

After several years the Prairie Home Companion ritual faded in favor of other activities. Then Garrison Keillor left for New York. It was never the same again. Keillor's first New York program opening monologue opined that it was rather odd to be starting to broadcast from a city where most parked automobiles had a dashboard sign saying "No radio." That thought wasn't enough to hold us, however. We ceased to tune in, save on the very rare occasions when we were driving and could find nothing else to listen to.

A wave of publicity alerted me to the impending final program. I made certain to be at home to listen to the broadcast. With the exception of the telephone call from President Obama it was more or less the familiar program that we had started listening to in the 1970s. This final broadcast became a receptive sponge for melancholic feelings contrasting the unchanging nature of the program over 42 years and the totally changed nature of my life in the 42 years since the first broadcast.

### 4th Ward Alderman Sophia King So. Loop Townhall Meeting

Alderman Sophia King held her Fourth Ward Town Hall Meeting on this past Monday, July 18<sup>th</sup> at the Hilton Chicago Hotel on South Michigan Ave. Her opening remarks covered what she

considers the main theme of her first term which includes safety; good schools; youth engagement; and Safe Summer Initiative. She talked about repurposing the "Safe Passage workers" to extend their responsibilities for the summer months for parks and other hot spots. She would like to engage the community to take responsibility and get involved. (See graphic on the right). She encouraged the audience to engage in "positive loitering." Another push of her ward is affordable housing. She mentioned that the new planned buildings in the neighborhood will have affordable housing units in their buildings. In the public comment segment of the meeting, a number of citizens took to the microphone to voice their concerns. Among them was Tom LaCotta from the 910 S. Michigan Ave condo building who expressed great concern and frustration with the non-stop activities, 5-K runs, concerts in Grant Park which adversely affects the quality of life of residents bordering the Park. And, he added, this will only become worse when all the new buildings bring in even more residents. An owner of a spa newly opened on Dearborn Street is being harassed and her employees harassed by an individual who sleeps in the doorway and makes threats of physical harm. She has pursued this with the police and the states attorney and it continues to be a problem. In response, Robert Klich, commander of the 1<sup>st</sup> District Police acknowledged that many homeless also have mental health issues and there are options for how the police handle problems such as this. Dennis McClendon of South Loop Neighbors asked the alderman if billboard sign approval could be rescinded. She responded that they are already looking into this. The property manager of the Printers Square Condos, Lynn Junas, asked if all the alderman representing the South Loop could attend a neighborhood

### When Pokemon GO Meets the Real World

SABEL VAZQUEZ, JULY 19, 2016 Pokemon GO is an exciting app that encourages people to explore the world around them: This is the popular narrative about the augmented reality game that in just one week had daily users approaching Twitter numbers in the US, according to SimilarWeb.



But this narrative ignores some seri-

ous limitations of *who* gets to do this exploration and *where* they choose to do it.

Though Pokemon GO seems to create a fantasy world around us, it exists within our very real world, filled with very real problems.

In the article Warning: Pokemon GO Is a Death Sentence If You Are a Black Man, writer Omari Akil describes having to keep his excitement in check while playing the game: "There is a statistically disproportionate chance that someone could call the police to investigate me for walking around in circles in the complex."

Writer Selena Larson also points out, in How Pokémon Go Is Creating a Barrier for Gamers With Disabilities, that the locations where many pokemon are found (e.g. at the top of a rocky hill) are not always accessible to people in wheelchairs and the egg-hatching feature requires people to walk long distances.

Not everyone has equal, safe access to exploration.

For people who do have access, they may still choose to remain in areas that are familiar.

What the narrative about Pokemon GO ignores is that our world is already full of invisible boundaries that people draw, because of real-world considerations like safety, ability and prejudice. Before giving Pokemon GO too much credit for bringing people out and interacting with the world, it's important to remember the limitations of that exploration.

There are some geolocation apps seeking to encourage exploration that could break some of those boundaries, like the app Vamonde. Vamonde users download location-based "adventures" (i.e. walking tours) that unlock stories as the user travels through them. Anyone can create a story, which has exciting implications for neighborhoods that do not always have control over the stories told about them. Vamonde encourages people to visit different parts of Chicagoland and learn about those areas from the people who are local to the area.

For example, the tour "Hell No, We Won't Go," created by University of Chicago student and activist Cosette Hampton, brings users on a tour of the Pullman neighborhood starting at the Carter G. Woodson Library. There, the tour explains the library's history ending with recent YouTube footage of community members rallying to keep the library open. The tour continues to Chicago State University, the Pullman Porter Museum, Harold's Chicken Shack #27 and more. Along the way, there is history, quotes from residents and photos.

Vamonde and Pokemon both push users to interact with the world in new ways. As people increasingly wonder how Pokemon GO can also be used as a tool for storytelling, and even journalism, we need to ask: who will those stories be for and who will they be about?

We need to be having a broader discussion about the limitations of "exploration."

We need to consider who is left out and we need to consider the boundaries of where people choose to explore. After all, it will take more than just technology and a quest to "Catch 'em All" to recode bias.

CHICAGO — A 21-year-old man died after being shot while driving on Lake Shore Drive downtown Sunday night, according to police.

The man was a passenger in a car driving southbound in the 600 block of South Lake Shore Drive at 10:40 p.m. Sunday when shots rang out from a dark-colored SUV, said Officer Jose Estrada, a Chicago Police spokesman.

He was struck in his lower back, Estrada said. The driver of the car abandoned the shooting victim in the first block of East 35th Street, where emergency responders found the man, Estrada said.

The man was brought to Northwestern Memorial Hospital in critical condition before he was pronounced dead, Estrada said.

The man is a documented gang member, according to police. No arrests have been made.

There have been eight shootings so far this year along Lake Shore Drive, up from two shootings over the same period last year on the Drive.
